RE: FINAL NOTICE OF DEMAND FOR FULL REPAYMENT OF USD 255,000

Dear Mr. Davuth,

We act for Mr. Chan Kam Fung Jone (hereinafter "Our Client").

We would like to inform you that we have yet received any response from you regarding our Client's demand of settlement of the sum of USD255,000, which you are supposed to refund to our Client by 25 June 2020. Despite several reminders through phone calls and written demand letters, you still have not responded to our Client.

Due to your failure to timely settle the above sum, our Client now demands you to fully refund the principal sum of USD255,000 to our Client by no later than 04 August 2020. We also wish to inform you that our Client has recorded significant increase of interest and damages incurred to it by your misconduct and reserves full legal and contractual right to claim for all interest and damages according to the applicable law.

This is the final notice from our Client and it is aimed at giving you an opportunity to appear before us and take responsibility for your misconduct. Should you fail to contact us to settle our Client's demand by close of business on 04 August 2020, our Client has firmly instructed us to take legal action to recover principal sum, interest and damages including legal costs which you have caused to our Client, without any further notice.
